

## NOTICE TO PROPOSERS

NOTICE IS HEREBY GIVEN that the City of Weston, Florida, and Indian Trace Development District (collectively the "CITY") will be accepting sealed proposals for:

# ITDD STORMWATER PUMP STATIONS RIGHT-ANGLE GEAR & PUMP REHABILITATION REQUEST FOR PROPOSALS ("RFP") NO. 2018-03

The City is requesting proposals from qualified and experienced firms to provide Indian Trace Development District (ITDD) Stormwater Pump Stations Right Angle-Gear & Pump Rehabilitation.

Proposers shall furnish mobilization, labor, supervision, equipment, supplies, tools, materials, all necessary incidentals, testing, report and safety measures to perform a complete rehabilitation of seven (7) sets of the right-angle gear pump shaft drives & pumps for ITDD Stormwater Pump Stations Nos.1 & 2, including but not limited to, check and reset the right-angle gears, check the shaft straightness, reblade and balance the impellers, replace all bearings, wear rings, seals, gaskets, lubrication system, all other replaceable internal components, replace all hold down bolts, sandblasting to bare metal, prime coat and painting. Also included in this proposal is the cost of the rigging, dismantling, transport, reassembly of the units, start up, alignment and vibration testing.

# **EXPERIENCE**

Proposers shall have a minimum of five (5) years of experience with the installation, and rehabilitation and testing of right-angle gear shaft driver, large axial & mixed flow propeller (36 inches or greater) stormwater pumps of a similar scope as those services desired by the City. Proposers shall have been in continuous operation for a minimum of the past five (5) years from the date that the RFP is issued and shall have a resident branch office in Monroe, Miami-Dade, Broward or Palm Beach County, Florida.

# PROPOSAL SUBMITTAL DEADLINE

Submittals shall be received by the City Clerk until 11:00 a.m., local time, July 10, 2018 (the "Proposal Submittal Deadline") at City of Weston, City Hall, located at 17200 Royal Palm Boulevard, Weston, Florida. The official clock at the City Hall reception desk shall govern. Submittals received after this time shall be returned unopened. The sealed submittals will be publicly opened at the City of Weston, City Hall after the Proposal Submittal Deadline. Award of a proposal will be made at a City Commission meeting.

#### MANDATORY PRE-PROPOSAL CONFERENCE

A mandatory pre-proposal conference shall be held on June 21, 2018 at 2:00 P.M., local time, at the Weston Community Center, located at 20200 Saddle Club Road, Weston, Florida 33327. All Proposers planning to submit a proposal are required to attend this conference. Proposers shall allow sufficient time to ensure arrival prior to the indicated time. Failure of a proposer to be present for the entire mandatory pre-proposal conference, beginning at the time stated above and concluding at the dismissal of the mandatory pre-proposal conference by the City, shall render a proposer to be deemed non-responsive and the proposal shall not be considered for award. Decisions of the City shall be final. The official clock at the location of the pre-proposal conference shall govern.

#### PROPOSAL SECURITY

Proposal security in the form of a proposal bond acceptable to the City or a cashier's check made payable to the "City of Weston" in the amount of \$5,000.00 or 5% of the total proposal cost, whichever is greater, will be required to be submitted with the proposal.
