initiative called SPLASH to combat the incidence of drowning, especially in young children, where hundreds of children will learn water safety and drowning prevention techniques.

TAKE STEPS NOW TO BE PREPARED New Applications Needed for Special Medical Needs Shelters

HURRICANE PREPAREDNESS – A Continuing Series

• THERE IS A CHANGE IN MEDICAL PROVIDER AT THE SPECIAL MEDICAL NEEDS SHELTERS AND NEW APPLICATIONS ARE NEEDED FOR THE 2010 HURRICANE SEASON.

Effective June 1, 2010, medical services provided in the Special Medical Needs Shelters during a disaster or other emergency will be transitioned from the Broward County Human Services Department to the Broward County Health Department. This results in a change in medical provider to the Health Department, and therefore a new application from all current registrants is needed. All applications will be evaluated using the Florida Department of Health eligibility criteria.

If you are currently registered in the Special Medical Needs Registry, you should have received an application and letter of instruction from the Broward County Health Department. The application needs to be completed with the assistance and approval of your physician. Applications are also available online by visiting www.broward.org/atrisk, click **MEDICAL NEEDS** and select **SHELTER AND TRANSPORTATION ASSISTANCE APPLICATION.**

On June 30th, members of the North Broward Hospital District were presented a city proclamation by Mayor Eric Hersh honoring the 10th Anniversary of Broward Health Weston.

The Hospital District held its regular meeting at the Weston location, to enable board members to take part in the 10th anniversary celebration and to honor 12 Broward Health Weston employees who have worked at the facility since its grand opening in June 2000.

Originally named the Weston Regional HealthPark, Broward Health's Weston location was the first public healthcare in our city,

built to meet the needs of a growing community. The 78,000 square foot facility offers a wide range of services including a Same Day Surgery Center, complete diagnostic imaging services, Women's Center, Urgent Care Center and Sleep Disorders Center.





Broward Health Weston (BHW) has always been, and continues to be, here **for** the community, but just as importantly, it is a **part** of the community. A perfect example of that involvement is this past weekend's Weston Hometown Annual 5K Run/Walk sponsored by Broward Health Weston.

MOTORISTS TO BE KEPT INFORMED DURING I-595 CONSTRUCTION

The I-595 Corridor utilizes an Intelligent Transportation System, a blend of electronic devices (cameras, vehicle detectors and message signs) monitored by the Traffic Management Center staff, to improve the flow of traffic and heighten the safety of motorists. With the I-595 Express Corridor Improvements project underway, the roadway is being widened into areas where cables are buried, and where poles are holding the overhead message boards, cameras and vehicle detectors.

In order to keep information flowing to motorists regarding the travel conditions on I-595 throughout the construction project, an interim system has been developed. That system is called the Interim Traffic Management System (**ITMS**), a wireless system that utilizes 26 portable trailers to house equipment. Trained, traffic management center staff collects the data provided by the system analyzes it and releases it in the form of traffic alerts.

Alerts are posted on the electronic message boards, recorded on the 511 traveler information telephone system, posted on traffic websites, and broadcast to the media.

Ultimately, the ITMS allows dispatchers to immediately notify responders such as Florida Highway Patrol to an accident, or Road Rangers to a troubled or brokendown motorist and decrease response time.

Once construction of the I-595 project is complete, the interim system will be replaced with a permanent system that will boast four-time the number of closed circuit cameras and vehicle detectors as well as five additional overhead message boards.

In 1981, Mike was hired with the Broward County Fire Department full time and has since rose through the ranks of fire fighter, fire fighter/paramedic, driver/engineer, lieutenant, captain and retired at the rank of battalion chief.

FREE RESIDENTIAL BULK TRASH PICK-UP

Wednesday, July 21st; Thursday, July 22nd; Friday, July 23rd; and *Saturday, July 24th

Bulk trash will be picked up <u>only</u> on your regularly scheduled collection day. Bulk trash must be placed curbside by 7 a.m. For residences with dumpster service, place items alongside dumpster. *Indicates pick-up for multi-family units (condominiums & apartment complexes). Occasionally bulk trash is not collected on its regularly scheduled collection day due to heavy volume, if this occurs it will be collected the following day.

THINK BEFORE YOU THROW - Consider donating before tossing

Help those in need, keep items out of the waste stream, and get a tax deduction. Several national organizations will even pick-up directly from your residence – you don't even have to wait for bulk pick-up day! There are many local, well-established charitable organizations that readily accept donated items.
