

BSO FIREFIGHTER WILLIAM CARR MOURNED 30-year veteran firefighter proudly served Weston

It is with deep sympathy that we inform the community of the death of BSO Firefighter William Carr, assigned to Fire Station 67, located on Saddle Club Road in Weston. Firefighter Carr had proudly served in Weston for the past eight years.

Firefighter Carr, 53 years of age and a 30-year veteran firefighter, was tragically struck by lightning while riding his motorcycle, on vacation and in route to visit the International Association of Fire Fighters Fallen Firefighter Memorial in Colorado Springs on June 12th. Carr had been wearing a helmet, but his injuries from the lightning strike and resulting crash, were too severe to overcome. He passed away Tuesday evening, June 15th in a Colorado hospital.

Carr will be honored with a traditional firefighter's funeral on Wednesday, June 23, 2010 at 11:00AM at St. Coleman's Catholic Church in Pompano Beach.

The death of Firefighter William Carr is a tremendous loss to his family, The Broward Sheriff's Office Department of Fire Rescue, his friends, colleagues and our Weston community.







HOW TO USE A ROUNDABOUT

With new roundabouts being constructed at two intersections on Bonaventure Boulevard in Weston, here's a reminder of the protocols and traffic laws regarding the use of a roundabout.

Vehicles

1. Yield at Entry

As you approach the roundabout there will be a yield sign and dashed yield limit line. Slow down, watch for pedestrians and bicyclists, and be prepared to stop if necessary. Yield to circulating traffic on the left, but do not stop if the way is clear.

2. Slow Down

Drive at a slow speed through the roundabout. The posted speed limit in the roundabout is 15 mph.

3. Yield to Pedestrians

Pedestrians have the right of way as in any other marked crosswalk.

4. Yield to Bicycles

Bicyclists have the same rights and responsibilities as motorists when riding in the roundabout.

Do not turn in front of or "cut off" a bicycle when exiting the roundabout.

5. Yield to Emergency Vehicles

Pull over **after** exiting the roundabout. Do not stop while still inside the roundabout.

Pedestrians

1. Use Roundabout Crosswalks

Walk around the perimeter of the roundabout, using the crosswalks.

Do not cross the roadway to the central island.

2. Watch for Traffic

Look and listen for approaching vehicle traffic and bicycle traffic.

Choose a safe time to cross. Try to make eye contact with approaching drivers.

Bicycles

1. Ride with Traffic

While roundabouts don't have striped bike lanes, traffic moves slowly, allowing cyclists and motorists to more effectively share space. Merge into the appropriate travel lane as you approach the roundabout, through proceed the roundabout, and merge back onto the shoulder after exiting the roundabout.

A random and unexpected inspection by Florida Bureau of Emergency Medical Services compliance inspectors of the Broward Sheriff Fire Rescue's Emergency Medical Services on June 16th produced top marks.

The State EMS team conducts scheduled and unscheduled inspections of all EMS providers in the state every two years. The inspectors look at personnel and service records, facilities and inspect Advanced Life Support (ALS) vehicles and equipment.

Excellent personnel records. All ALS units were clean and well supplied." 


CONGRATULATIONS TO CITY TREASURER DARREL THOMAS
