## PROPOSED IMPROVEMENTS

- A new ramp connecting eastbound SR 84 to southbound SR 93/I-75
- Auxiliary lanes along southbound SR 93/I-75
- Add a third westbound left turn lane at Royal Palm Boulevard and Weston Road
- Widen SR 93/I-75 southbound ramp (Ramp C) to Royal Palm Boulevard from one lane to two lanes
- Add a third right lane at the intersection of the southbound off-ramp at Royal Palm Boulevard
- New drainage, signage, pavement markings, signals, and lighting within the project limits
