NOTICE IS HEREBY GIVEN that the City of Weston, Florida, (the "City") will be accepting sealed bids for:

**WESTON TENNIS CENTER IMPROVEMENTS  
BID NO. 2020-02**

Bids shall be accepted from qualified and experienced licensed general contractors to furnish all labor, supervision, equipment, supplies, tools, permitting, safety measures and all other necessary incidentals for improvements at the Weston Tennis Center located at 16451 Racquet Club Road, Weston, Florida 33326. Scope of work includes interior renovation of the existing Pro Shop and construction of four new Pickle Ball courts and two new Padel Ball Courts. The interior renovations at the Pro Shop includes, but not limited to, complete renovation of existing restrooms; wall, ceiling, and floor finishes; lighting upgrades; and patio floor and ceiling finishes.

Simultaneous with the delivery of the executed contract to the City, the Contractor shall furnish an executed Performance and Payment bond in an amount equal to one hundred percent (100%) of the contract value, as security for the faithful performance of contract and for the payment of all persons performing labor and/or furnishing materials in connection with the Project.

The official clock at the City Hall reception desk shall govern. Bids received after this time shall be returned unopened.
