Mayor Stermer stated, on behalf of the Arts Council of Greater Weston it is my honor to announce the recipient of their inaugural Student Volunteer Scholarship being awarded to Tomas Guerra, a 19-year-old senior from Cypress Bay High School.

This year's award is in the amount of \$1000. Claudia Fernandez, a Cypress Bay High School Teacher and Arts Council Board member, proposed and spearheaded this new program. She states, "The Student Volunteer Scholarship was opened to Arts Council volunteers to honor their contributions to our organization. It recognizes the student's efforts on behalf of arts and culture events in our community. Without the many hours that these students have contributed, our major events would not have been possible".

In addition to volunteer hours, other criteria included grades, classwork in the arts, music, languages and creative writing, a recommendation letter, work, other extracurricular activities, and an essay from the student. A selection committee chose Tomas as the recipient of the scholarship.

Tomas arrived in the United States from Venezuela at the beginning of his junior year. He immediately adapted to a new and completely different lifestyle and language. He was in the top 10% of his graduating class. He joined the Spanish Club from CBHS, and through it, found the Art Council of Greater Weston. He volunteered with the Arts Council throughout his two years of high school at different events such as Celebrate the Arts Day and Weston World Fest.

In these two years, he also worked and enhanced his leadership skills by becoming the President of the Spanish Club in Cypress Bay. In his year as President, he focused the club onto more service activities and experiences that enhanced the fraternity within the club. He has worked as a self-employed tutor from September 2015, while still in Venezuela, through the present, He thinks it is important that wherever you are in this world, you must be part of your community. He will pursue a career in International Relations at Florida International University.

In his thank you note to the Arts Council, Tomas wrote, "I wanted to thank you for this amazing opportunity! Thank you for believing in me and in my future education. I got this email at the right

time. I've worked hard in these past 2 years in the US, and I'm really grateful for the Arts Council to cherish that, and support me on my educational journey. I hope you, and all of the Arts Council is staying safe and healthy; and that we could meet after quarantine is over to thank you all personally".

President Jami Nix Rahn adds, "Tomas was selected based on his positive attitude and commitment to the community. Unfortunately, we were not able to recognize this outstanding student at our annual Volunteer Reception due to the Covid-19 social distancing orders. We wish him great success in his future endeavors. Finally, we appreciate the Mayor and Commission for helping us let the community know about this very talented Weston student.

 country and here locally, in Broward County which have turned violent, which last night caused
 a last-minute curfew to be put into effect here in Broward which was sent out by the Broward
 County Emergency Notification System. We want our community to know that Chief Butler is
 closely monitoring all events taking place and is taking appropriate measures to protect our
 community.
