

NOTICE TO PROPOSERS

NOTICE IS HEREBY GIVEN that the CITY of Weston, Florida (the "CITY") will be accepting sealed proposals for:

INVESTMENT CUSTODIAL SERVICES REQUEST FOR QUALIFICATIONS ("RFQ") NO. 2020-04

The CITY is requesting proposals from qualified firms to provide Investment Custodial Services for the CITY's fixed-income securities purchased in accordance with the CITY's Investment Policy and settled on a Delivery-versus-Payment (DVP) basis. Services shall include the receipt and holding of securities, collection and distribution of investment income and sales/maturity proceeds of investments, wiring funds to the account on a same-day basis, and reporting.

The CITY currently keeps an aggregate of approximately \$130 million in two safekeeping accounts. Only one safekeeping account is used for trade settlements. Each safekeeping account contains a money market mutual fund into which and from which cash activities are settled. Cash is wired in and out of the money market mutual funds as the City's cash availability requires. The City's trading activity averages 15 trades per quarter.

All Proposers are advised that the CITY has **NOT** authorized the use of CITY's seal by individuals or entities responding to the CITY's RFQ, and that any such use by unauthorized persons or entities constitutes a second-degree misdemeanor pursuant to Section 165.043, Florida Statutes.

PROPOSER QUALIFICATIONS

Proposers shall have a minimum of five (5) years of providing investment custodial services and shall meet the following qualifications:

- a) Be a Florida chartered institution and/or be approved by the Federal Reserve Bank.
- b) Compliance with the CITY's investment policy (attached as Appendix A).
- c) Real-time or daily reporting and analytics tools as well as internet access to these products.
- d) An internet-accessible real-time or daily inventory management system.
- e) Provide electronic trade entry process.
- f) Ability to integrate via file transfer protocol with the Clearwater Analytics web-based investment portfolio accounting, reporting, and reconciliation Software.

Proposers shall be a fully licensed with all required Federal, State and Local government licenses/permits.

Proposers shall have been in continuous operation for a minimum of the past five (5) years from the date that the RFQ is issued and shall have a branch office in Miami-Dade, Broward or Palm Beach County, Florida. Proposer shall have staff that have all required Federal, State and Local government licenses and registrations.

PROPOSAL SUBMITTAL DEADLINE

Submittals shall be received by the Procurement Manager until **11:00 a.m., local time, on November 10, 2020** (the "Proposal Submittal Deadline") at CITY of Weston, CITY Hall, located at 17200 Royal Palm Boulevard, Weston, Florida. The official clock at the CITY Hall reception desk shall govern. Submittals received after this time shall be returned unopened. The sealed submittals will be publicly opened and at the CITY of Weston, CITY Hall after the Proposal Submittal Deadline. Award of a proposal will be made at a CITY Commission meeting.
