

NOTICE TO PROPOSERS

NOTICE IS HEREBY GIVEN that the CITY of Weston, Florida (the "CITY") will be accepting sealed proposals for:

INSTALLATION OF SHADE STRUCTURES REQUEST FOR PROPOSALS ("RFP") NO. 2020-05

The CITY is requesting proposals from qualified firms licensed as a Certified General Contractor, Certified Building Contractor or Specialty Structure Contractor by the State of Florida for installation of shade structures at various CITY parks.

Proposer shall be responsible for all aspects of the work; including, but not limited to, all labor, supervision, equipment, supplies, tools, materials, and all other necessary incidentals required to perform needed installations, in accordance with applicable Federal, State, Local government regulations.

All Proposers are advised that the CITY has **NOT** authorized the use of CITY's seal by individuals or entities responding to the CITY's RFP, and that any such use by unauthorized persons or entities constitutes a second-degree misdemeanor pursuant to Section 165.043, Florida Statutes.

PROPOSER QUALIFICATIONS

Proposers shall have a minimum of five (5) years of providing installation of shade structures to other entities with shade structures of a similar size, type, and complexity as those owned and maintained by the CITY. Proposers shall be fully licensed with all required Federal, State and Local government licenses/permits.

Proposers shall have been in continuous operation for a minimum of the past five (5) years from the date that the RFP is issued. Proposer shall have staff that have all required State and Local government licenses and registrations.

PROPOSAL SUBMITTAL DEADLINE

Submittals shall be received by the Procurement Manager until 11:00 a.m., local time, on December 1, 2020 December 4, 2020 December 9, 2020 (the "Proposal Submittal Deadline") at CITY of Weston, CITY Hall, located at 17200 Royal Palm Boulevard, Weston, Florida. The official clock at the CITY Hall reception desk shall govern. Submittals received after this time shall be returned unopened. The sealed submittals will be publicly opened and at the CITY of Weston, CITY Hall after the Proposal Submittal Deadline. Award of a proposal will be made at a CITY Commission meeting.
