

NOTICE TO PROPOSERS

NOTICE IS HEREBY GIVEN that the City of Weston, Florida, Indian Trace Development District and Bonaventure Development District (collectively the "CITY") will be accepting sealed proposals for:

SUPPLEMENTAL LANDSCAPE MATERIALS AND INSTALLATION SERVICES REQUEST FOR PROPOSALS ("RFP") NO. 2021-03

The City is requesting proposals from qualified firms to provide supplemental landscape materials and installation services on an ongoing, or as needed basis, and at the sole discretion of the City.

Proposers shall provide all labor, supervision, equipment, supplies, tools, materials, and all other necessary incidentals required to provide supplemental landscape materials and installation services, excluding athletic fields, in the City of Weston.

These services are intended to be supplemental to and separate from the City's existing agreements for Comprehensive Landscape Maintenance Services and Parks Maintenance Service. The City may select at least two firms, the top ranked proposer, and the second ranked proposer, and if determined to be in the best interest of the City, and additional proposers, in order of rank. Firms with other existing agreements with the City may submit proposals.

All Proposers are advised that the CITY has **NOT** authorized the use of CITY's seal by individuals or entities responding to the CITY's RFP, and that any such use by unauthorized persons or entities constitutes a second-degree misdemeanor pursuant to Section 165.043, Florida Statutes.

PROPOSER QUALIFICATIONS

A proposal will only be considered from a firm that is regularly engaged in the business of providing landscape materials and installation services required by this solicitation. The proposer must be able to demonstrate a record of exceptional performance and have sufficient financial resources, equipment and organization to ensure that they can satisfactorily provide the goods and/or services.

Proposers shall have a minimum of five (5) years of experience from the date that this RFP is issued, in providing landscape materials and installation services of a similar scope, complexity and size as those services managed by the City.

Proposers shall have been in continuous operation for a minimum of the past five (5) years from the date that the RFP is issued and shall have a primary or branch office in Miami- Dade, Broward or Palm Beach County, Florida. Proposer shall have staff that have all required State and Local government licenses and registrations.

MANDATORY PRE-PROPOSAL CONFERENCE

A pre-proposal conference shall be held on virtually on **April 14, 2021 at 10:30 a.m.**, local time. All Proposers planning to submit a proposal are required to attend this conference. Failure of a Proposer to be present for the entire mandatory pre-proposal conference, beginning at the time stated above and concluding at the dismissal of the mandatory pre-proposal conference by the CITY, shall render a Proposer to be deemed non-responsive and the proposal shall not be considered for award. Decisions of the CITY shall be final.
