

NOTICE TO PROPOSERS

NOTICE IS HEREBY GIVEN that the CITY of Weston, Florida (the "CITY") will be accepting sealed proposals for:

PARKS AND RECREATION MASTER PLAN SERVICES REQUEST FOR QUALIFICATIONS ("RFQ") NO. 2021-04

Pursuant to Section 287.055, Florida Statutes, the CITY requests proposals from qualified and experienced firms to provide professional services for the development of a municipal parks and recreation master plan (the "PRMP"), not exceeding the dollar threshold limits pursuant to Section 287.055 Florida Statutes as amended from time to time.

The principal rationale for a development of a PRMP is to provide an optimal delivery system for park and recreation services and define present and future recreation needs for the community, consistent with the socio-economic, psycho-demographic and development trends within the City. The master plan provides recommendations for provision of facilities programs and services, land acquisition and development, maintenance, operations and management.

All Proposers are advised that the CITY has **NOT** authorized the use of CITY's seal by individuals or entities responding to the CITY's RFQ, and that any such use by unauthorized persons or entities constitutes a second-degree misdemeanor pursuant to Section 165.043, Florida Statutes.

PROPOSER QUALIFICATIONS

Proposers shall be professionally licensed in the State of Florida to practice engineering, planning or a related field and have a resident office in the State of Florida.

Proposers shall have been in continuous practice for a minimum of the immediate past ten (10) years, shall have performed work for local governments in Southeast Florida and shall have completed at least two parks and recreation master plans for a government agency with infrastructure similar in scope, size and complexity as those owned and managed by the City of Weston.

Proposer shall have staff that have all required Federal, State and Local government licenses and registrations.
