

NOTICE TO PROPOSERS

NOTICE IS HEREBY GIVEN that the City of Weston, Florida, Indian Trace Development District and Bonaventure Development District (collectively the "CITY") will be accepting sealed proposals for:

PRESSURE CLEANING SERVICES REQUEST FOR PROPOSALS ("RFP") NO. 2022-02

The CITY is requesting proposals from qualified firms to provide Pressure Cleaning Services at various municipal facilities.

Proposers shall provide all labor, supervision, equipment, supplies, tools, materials, MOT, and all other necessary incidentals required to provide pressure cleaning services at various facilities throughout the City of Weston. The CITY may select at least three firms, if determined to be in the best interest of the City. Firms with other existing agreements with the CITY may submit proposals.

All Proposers are advised that the CITY has **NOT** authorized the use of CITY's seal by individuals or entities responding to the CITY's RFP, and that any such use by unauthorized persons or entities constitutes a second-degree misdemeanor pursuant to Section 165.043, Florida Statutes.

PROPOSER QUALIFICATIONS

Proposals will only be considered from firms that are regularly engaged in the business of providing pressure cleaning services as required in this solicitation. Proposers must be able to demonstrate a record of exceptional performance and have sufficient financial resources, equipment and organization to ensure that they can satisfactorily provide the services required.

Proposers shall have a minimum of five (5) years of experience from the date that this RFP is issued, in providing pressure cleaning services of a similar scope, complexity and size as those services managed by the City.

Proposers shall have been in continuous operation for a minimum of the past five (5) years from the date that the RFP is issued and shall have a primary or branch office in Miami- Dade, Broward or Palm Beach County, Florida.
