- 3. Q: On Form 2 (Proposer Reference Form), is the City looking for references from the prime proposer only or may the minimum three references be met using one or more subconsultant references?
 - A: Only the Prime consultant.
- 4. Q: Can you please let us know the duration of this contract?
 - A: The term of this Agreement shall begin on the date it is fully executed by both parties and shall extend until March 31, 2025. After the initial term, the Contract may be extended for one (1) additional three-year period by mutual agreement of the parties.
- 5. Q: In addition, are 330 forms required from our team of subconsultants or is only the prime required to submit a 330 form?
 - A: Only the Prime consultant.

- 6. Q: Are the insurance requirements on pages 57-58 for the Prime and our subconsultants or only for the Prime?
 - A: The insurance requirements will need to be met by the Prime.
- 7. Q: Is there any limitation on the number of teams a subconsultant may join if the firm is not a Prime on any proposal?
 - A: No.
- 8. Q: What information does a subconsultant need to provide, simply beyond being on the list of the prime?
 - A: Refer to the directions included as part of the RFQ.
- 9. Q: Does the Prime need to identify what specific service the subconsultant needs to provide, or simply identifying a firm as a subconsultant sufficient?
 - A: Refer to the directions included as part of the RFQ (see section 4.3, Sealed Proposal, for a list of information required).
- 10. Q: Is there any requirement/preference for the prime as well as the subconsultant firm being a Small and/or Minority Business?
