Proposers for the above referenced Request for Proposals ("RFP') shall take note of the following changes, additions, deletions, clarifications, etc., to the RFP documents, which shall become a part of and have precedence over anything shown or described otherwise.

## A. CHANGES IN THE RFP DOCUMENTS

## C. QUESTIONS FROM PROPOSERS:

- 1. Q: Will the \$5,000.00 proposal security be returned to the proposers not awarded?
  - A: The proposal securities shall be returned subsequent to execution of the Agreement by the successful Proposer and the appropriate City officials.
- 2. Q: Are Proposers required to have a local office prior to the proposal due date?
  - A: Yes, Proposers shall have a primary or branch office in Miami- Dade, Broward or Palm Beach County, Florida.
- 3. Q: Typically, a performance and payment bond is not required for these services, are proposers required to submit a performance and payment bond?
  - A: Yes, the awarded Contractor will be required to provide a performance and payment bond equal to \$750,000.00.
- 4. Q: If the number of guards required increases over 79, will an additional supervisor be required?
  - A: No, the current three supervisors required would suffice.
- 5. Q: Is the \$250.00 penalty per occurrence for locations not staffed negotiable?
  - A: No, the \$250.00 penalty is not negotiable.

- 6. Q: Is the City looking for rates for the entire five-year term, or are proposers to provide a rate for each year?
  - A: Proposers are to provide single rates for the five-year term. However, the City will apply an annual adjustment to the rates, based on the annual change to the applicable Consumer Price Index.
- 7. Q: What is the hourly bill rates under the agreement with the City?
  - A: Current hourly bill rate is \$21.39 for both crossing guard and supervisor positions.
- 8. Q: Is there a minimum pay rate required?
  - A: Minimum pay rate shall be in accordance with the State of Florida requirements.
- 9. Q: Is there a daily hourly minimum required for the crossing guards?
  - A: See section 2.3, Crossing Guards Required (page 48), of the Agreement Document.
- 10. Q: Is the \$250.00 penalty per occurrence new to the contract? If not, have you had to utilize it in the past?
  - A: It is not new to the contract. No, we have never had apply the penalty under the current agreement.
- 11. Q: What department would these services fall under?
  - A: Communications Department.
- 12. Q: What is the current hourly pay rates for the crossing guards?
  - A: This information is not readily available to the CITY. However, current payrates must be in accordance with the State of Florida requirements.
- 13. Q: For the Proposal Security, can firms send the \$5,000 via wire transfer or company check?
  - A: The Proposal security in the form of a proposal bond acceptable to the CITY or a cashier's check made payable to the "City of Weston" in the amount of \$5,000.00 will be required.
