Bidders for the above referenced Bid shall take note of the following changes, additions, deletions, clarifications, etc., to the bid documents, which shall become a part of and have precedence over anything shown or described otherwise.

A. CHANGES IN THE BID DOCUMENTS

1. The following clause is being added to Document 00100, Instruction to Bidders:

ARTICLE 37.0
SOCIAL, POLITICAL, OR IDEOLOGICAL INTERESTS

Bidder's social, political, or ideological interests shall not be considered when determining responsiveness and/or responsibility of bid submittal.

B. CLARIFICATIONS

C. QUESTIONS FROM BIDDERS

1. Q: What is the estimated budget for this project?

A: The estimated budget is \$150,000.00.

2. Q: Since some of the work is required by a school site, do we need to be pre-badged?

A: No, pre-badging is not necessary.

3. Q: Is it a 400 meter track?

A: Yes.

4. Q: What is the state of the current state of the existing track and what type of surfacing?

A: It is 8 year old asphalt.

5. Q: Would Hellas' EpiqTracks V300 be considered as an equal product?

A: Yes, the EpiqTracks V300 may be considered as an equal product.

6. Q: Is the standard ed color shown in the plan sheet to be used?
A: The color hasn't been determined yet. This may be something that administration will decide later as we get closer.
7. Q: When is the work scheduled to begin and is the start date flexible?
A: The project is scheduled need to begin after the football season, which ends late November.
8. Q: In the pre-bid we heard that Bermuda grass needed to be replaced or added somewhere, but I can't find this anywhere in the bid. Can you please provide the corresponding section of the bid?
A: No, bermuda-grass is included in the scope of work for this bid. Any damages to the surrounding landscaping will need to be restored by the contractor.
