Bidders for the above referenced Bid shall take note of the following changes, additions, deletions, clarifications, etc., to the bid documents, which shall become a part of and have precedence over anything shown or described otherwise.

### A. CHANGES IN THE BID DOCUMENTS

1. The following clause is being added to Document 00100, Instruction to Bidders:

**ARTICLE 37.0**  
**SOCIAL, POLITICAL, OR IDEOLOGICAL INTERESTS**

*BIDDER's social, political, or ideological interests shall not be considered when determining responsiveness and/or responsibility of bid submittal.*

### C. QUESTIONS FROM BIDDERS

1. Q: What is the estimated budget for this project?

A: The estimated budget is \$300,000.00

2. Q: Is the bid limited to general contractors or is open for fence CONTRACTOR as well?  
A: BIDDERS must be fully licensed general contractors.

3. Q: Is the standard ed color shown in the plan sheet to be used?

A: The color has not yet been determined. We will advise the awarded BIDDER.

4. Q: When is the work scheduled to begin and is the start date flexible?  
A: Project start will depend on material arrival and Racquet Club schedule.
5. Q: Is the repair of clay from removal of poles to be included in the pricing or will it be handled separately?  
A: Pricing must be all inclusive and repairs made by the awarded CONTRACTOR. All repairs must be made, and courts left fully operational.
6. Q: Will the CITY provide the paint color needed for repairs of the clay?  
A: The CITY will provide the color of the clay, should touch-ups be required by the CONTRACTOR.
7. Q: On the clay courts, is the CITY leaving the concrete for the old posts below grade?  
A: The CONTRACTOR is to use the same holes to pour the new footings.
8. Q: If we have done work for the CITY, where should it be disclosed?  
A: Any previous relationships, over the past five years, with the CITY must be disclosed on Document 00470, Independence Affidavits.
9. Q: Are there any specific gate latches/locks required?  
A: The CITY has its own locks to be utilized.
10. Q: Are there any wage requirements?  
A: There are no wage requirements for this project.
11. Q: We were unable to attend the mandatory virtual pre-bid conference. Is there any way that our company can be eligible to bid?  
A: Attendance to the Pre-Bid Conference was mandatory. Bids will only be considered from BIDDERS that actually attended the Pre-Bid Conference.
