To All Bidders:

Bidders for the above referenced Bid shall take note of the following changes, additions, deletions, clarifications, etc., to the bid documents, which shall become a part of and have precedence over anything shown or described otherwise.

A. CHANGES IN THE BID DOCUMENTS

1. Section 2.4(A), Residential Curbside Collection Services on page 62, has been revised to read as follows:


2.4 (A). Residential Curbside Collection Services

- 1. Residential Curbside Solid Waste Collection Service. Residential Curbside Service Units within the CITY shall receive automated Residential Solid Waste Collection twice per week with 60 to 65 gallon and 90 to 95 gallon Solid Waste Carts. Any loose palm fronds (a nominal quantity of naturally felled fronds for the Residential Curbside Unit and not landscape contractor generated cuttings) placed adjacent to the Residential Solid Waste Cart shall be collected concurrent with the cart collection on the first Collection of the week only. Once annually, the CONTRACTOR shall collect Christmas Trees from each Residential Curbside Service Unit when placed adjacent to a Cart.
- 2. Section 3.8 (B), Monthly Complaints and Missed Collection Reports Complaints on page 74, has been revised to read as follows:
 - 3.8 (B). Complaints: CONTRACTOR will maintain an accurate and up-to-date log of date, time, and address of all complaints received, including replacement and swap out cart requests, the disposition thereof, actions taken to resolve the complaint, and the date and time the complaint collection was resolved. The CONTRACTOR shall provide the complaint collections log to the CITY in the form of a monthly report in Microsoft Excel or in an alternative computer program selected by the CITY, no later than the fifteenth (15th) day of each month, or upon request by the CITY.

B. CLARIFICATIONS

The City of Weston contains neighborhoods that are gated (purple roads on map below) AS WELL as neighborhoods (blue roads on the following map) that are non-gated. Bidders can access the non-gated areas anytime. For those bidders wishing to gain access to one of the gated communities. Please meet City staff at:

C. QUESTIONS FROM BIDDERS

1. Q: Section 2. 4 A 2 states "Residential Curbside Solid Waste Collection Service. Residential Curbside Service Units within the CITY shall receive automated Residential Solid Waste Collection twice per week with 60 to 65 gallon and 90-to-95-gallon Solid Waste Carts. Any loose palm fronds placed adjacent to the residential Solid Waste Cart shall be collected concurrent with the cart collection. How many loose palm fronds are allowed to be set out adjacent to the solid waste cart on each collection day?

A: See above revised language for Section 2.4 (A), as noted herein. Also see Answer to Question No. 20 in Addendum # 1. (Nominal quantity of naturally felled fronds for a typical home. Not meant to be used as collection of debris and cutting from homeowner's landscape contractor's work.

- 2. Section 2. 4, A 3 states- "Residential Curbside Bulk Waste Collection Service. The Contractor shall provide four (4) annual Collections per year at quarterly intervals for Bulk Waste from Residential Curbside Service Units on a schedule approved by the CITY. Additional Bulk Waste Collections shall be provided at the rate specified in the agreement. How many cubic yards of Bulk is a residential unit allowed to set out on each quarterly schedule collection day?
 - A: Please refer to Section 2.2, Definitions (page 57) for the definition of Bulk Waste.
- 3. Q: Are commercially generated tons (landscapers/contractors) allowed to deposit their material at the curb for bulk collection?
 - A: Please refer to Section 2.2, Definitions (page 57) for the definition of Bulk Waste.
- 4. Q: Section 3.7 A 2 states List of all weight tickets at the point where the Solid Waste and Recyclable Materials were first tipped for Solid Waste and Recyclables collected in the CITY during the previous semi-annual year, including route number, date, and Solid Waste or Recyclable quantity. Does this requirement exist in today agreement with the current service provider? If so, can the CITY please provide the last semi-annual report of all the weight tickets?
 - A: Please refer to answer to Question # 10 in Addendum No. 1.
- 5. Q: With proper and city approved notices, Will the successful bidder be allowed to change any of the service days (not contracted frequency) for Residential Solid Waste, Recycling and Bulk collection?
 - A: Please refer to Section 3.4, Residential Curbside Schedules, and Routes (page 70).
- 6. Q: Can the City provide access to all the gated communities this week so the bidders can survey the City Bulk collection which is occurring this Wednesday, Thursday, and Friday of this week?
 - A: See Section B, Clarifications, as noted herein.
