A. CHANGES IN THE BID DOCUMENTS

1. Exhibit B, Fee Schedule, Cost Form 2 and Cost Form 3 (pages 116 and 117) have been revised to read as below. Notably, the Non-compacted and Compacted Disposal Rate shall be per ton and NOT per cubic yard. A Revised Cost Form 2 and Revised Cost Form 3, is attached herewith.

2. Q: If the CITY changes the Compacted Disposal Rate from a cubic yard to a per ton rate, will it please also update Cost Forms 2 (B) and 3 (B) to reflect this change?

3. Q: Since the residential containerized collection rate / yard is to include the cost of recycling collection, please provide the number of units there are per multi-family customer to be able to calculate the recycling cart requirements for each multi-family customer.

A: The information is not unavailable.

4. Q: For residential containerized services, please confirm that the CONTRACTOR is to bill the HOA directly for these services.

A: See Section 3.5 – B, Residential Containerized Collection Services and Commercial Solid Waste Collection and Disposal Service, of the Agreement document (page 70).

5. Q: Does the CITY prefer a binder clip, loose paper, or a three-ring binder for submittal of the response hard copy documents?
