To All Bidders:

Bidders for the above referenced Bid shall take note of the following changes, additions, deletions, clarifications, etc., to the Bid documents, which shall become a part of and have precedence over anything shown or described otherwise.

A. CHANGES IN THE BID DOCUMENTS

1. The "BID SUBMITAL DEADLINE" Section of Document 00010, Notice to Bidders, is being changed to reflect a new Bid Due Date as follows:

BID SUBMITAL DEADLINE

Sealed bids shall be received by the Director of Procurement until **2:00 p.m. local time, on ~~October 21, 2024~~, October 28, 2024 (the "Submittal Deadline")** at the City of Weston, City Hall, located at 17200 Royal Palm Boulevard, Weston, Florida. The official clock at the City Hall reception desk shall govern. Bids received after this time shall be returned unopened. The sealed bids will be publicly opened at the CITY of Weston, City Hall after the Bid Submittal Deadline. Award of a Bid will be made at a City Commission meeting. The public opening of submittals may be viewed by the public via Cisco Webex as follows:

B. CLARIFICATIONS

None.

C. QUESTIONS FROM BIDDERS

1. Q: What is the estimated budget?

A: \$3.1 Million

2. Q: Who is responsible for testing in density and would include vibration monitoring and settlement?

A: The contractor is responsible for all testing required.

3. Q: Can you clarify Bid owner's contingency?

A: The contingency is for any additional scope not currently in the contract. It is for the City to use, not for the contractor to use. City will authorize use of owner's contingency for any scope changes, if required.

4. Q: Is the project federalized or funded by FDOT?

A: The project is partially funded by the Broward County surtax program.

5. Q: Work hours? Can the bidder pave during the night or only during the day?

A: Work hours are typically 7:00 am to 7:00 pm, Monday through Saturday. Daytime lane closures will be allowed west of Weston Rd between 9:00 am and 4:00 pm with some exclusions because of school zones. For all work at the Weston Rd intersection and east, lane closures will only be allowed at night from 8:00 pm to 5:00 am.

6. Q: What is the thickness of the rock or roadway pavers, and what type of material is required?

A: See question 14 which also deals with pavers.

7. Q: Are there any specific wages?

A: No.

8. Q: Please confirm there are no adjustments to the cost in fuel increase.

A: No cost adjustments for fuel.

9. Q: What are the pipe sizes and pipe length required?

A: All pipe sizes and lengths are to be determined in the field by the Contractor. Refer to revised bid form for pay items related to drainage modifications.

10. Q: When will construction start?

A: When the bid is awarded, and the contract is executed. This will likely be in December 2024 or January 2025.

11. Q: Can you please provide a set of drainage plans from Saddle Club Road to SW 160 Avenue on Indian Trace?

A: All drainage improvements are shown on the set of plans provided.

12. Q: Bid Item 0120-01 Regular Excavation 1,519/CY: does this item include any embankment

(fill) material? If so, what would that quantity be?

A: This item does not include any embankment (fill) material.

13. Q: Is the City able to provide cross section plans for any cut & fill area.

A: No, the City did not develop cross section plans.

14. Q: On plan sheet No. 9, Arch Roadway Pavers, Crossing Guard Parking Lane Detail; does not show the roadway template as to what material and thickness is to be used (sand layer, base-rock and subgrade)? Please clarify.

A: The roadway template underneath the roadway pavers will consist of Stabilization Type B, LBR 40 (12") and Optional Base Group 1, LBR 100 (4"). This information can be found on Sheet 6, Pavement Design for "Widening (Crossing Guard Parking Lanes)". The pavers are 2 and-3/8" thick.

15. Q: For Curb Pad detail, what is the thickness and material type?

A: Curb Pad should be 4" thick and will consist of Limerock, LBR 40 or B-12.5. Alternatively, existing granular material to be shaped and compacted, Min. LBR 40. The Construction Plan set will be updated to provide this information in the plan sheet

16. Q: Plan Sheet 34 & 35 of the roadway plans, Sta 137+72 to 141+35; show a gray shaded area on the outside of the proposed widening. Can the city please clarify what the area is?

A: The gray shaded area represents sod. The Construction plan set will be updated to show the correct sod pattern.
