RESOLUTION NO. 2024-104**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF WESTON, FLORIDA, AWARDED BID NO. 2024-05 FOR MILLING AND RESURFACING – PARKING LOTS TO ARROW ASPHALT & ENGINEERING, INC. D/B/A DIGGER O'TOOLE OF OPA LOCKA, FLORIDA.

WHEREAS, First, the City of Weston (the "City") owns, operates and maintains the facility parking lots throughout the City; and

WHEREAS, Second, funding is appropriated in the Fiscal Year 2024 Budget, Capital Projects Fund; and

WHEREAS, Third, Chapter 32 of the City Code governs the acquisition of goods and services and disposal of City property, including Milling and Resurfacing – Parking Lots, Bid No. 2024-05 (the "Bid"); and

WHEREAS, Fourth, in compliance with Chapter 32 of the City Code, beginning on May 24, 2024, the Bid was issued and advertised in the Sun-Sentinel, on the City's website, posted on the Public Notices board in the City Hall lobby, and bid documents were made available for electronic download from the City's website and Onvia DemandStar; and

WHEREAS, Fifth, on June 11, 2024, a total of fourteen (14) firms participated at the mandatory Pre-Bid Conference held virtually through Cisco Webex; and

WHEREAS, Sixth, on June 14, 2024, the City issued Addendum #1; on June 17, 2024 Addendum No. 2 was issued, on June 24, 2024 Addendum No. 3 was issued and on July 1, 2024 Addendum No. 4 was issued; and

WHEREAS, Seventh, on July 15, 2024, bids were due and opened and the City received six (6) sealed bids from: Metro Express, Inc. of Medley, Florida; M&M Asphalt Maintenance, Inc. D/B/A All County Paving of Delray Beach, Florida; Arrow Asphalt & Engineering, Inc. D/B/A Digger O'Toole of Opa Locka, Florida; Sun Eagle General Contractors Corporation of Miami, Florida; Janice M. Riley D/B/A The Paving Lady of Boynton Beach, Florida; and Weekley Asphalt Paving, Inc. of Pembroke Pines, Florida, as shown on the Bid Tabulation, attached as Exhibit "A"; and

WHEREAS, Eighth, on July 25, 2024, the Selection Committee consisting of Kara Petty, Director of Parks and Recreation; Cindy Tao, Director of Accounting; and Jerrylee Camacho, IT Manager, met at a publicly noticed virtual meeting held using Cisco Webex, to review the bids; and

WHEREAS, Ninth, the Bid included a total of forty-seven (47) bid items; and

WHEREAS, Tenth, in accordance with Article 27 of the Instructions to Bidders and in the best interest of the City, the Selection Committee has recommended for award only Bid Item Number 1 through Bid Item No. 38, plus Bid Item 47 – Owner's Contingency, for a total of thirty-nine (39) bid items as further detailed in Exhibit "A", which excludes the bid items (Nos 39 through 48) related to the construction of additional parking spaces at Tequesta Park; and

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF WESTON, FLORIDA, AWARDING BID NO. 2024-05 FOR MILLING AND RESURFACING – PARKING LOTS TO ARROW ASPHALT & ENGINEERING, INC. D/B/A DIGGER O'TOOLE OF OPA LOCKA, FLORIDA.

WHEREAS, Eleventh, the Selection Committee deemed all six firms as responsive and responsible and determined Arrow Asphalt & Engineering, Inc. D/B/A Digger O'Toole of Opa Locka, Florida as the responsible and responsive bidder with the lowest cost, in the total bid amount of \$777,764.48 for Bid Item Number 1 through Bid item No. 38, plus Bid Item 47 – Owner's Contingency; and

WHEREAS, Twelfth, the City Commission finds that the responsible and responsive bidder with the lowest cost for Bid No. 2024-05, Milling and Resurfacing – Parking Lots is Arrow Asphalt & Engineering, Inc. D/B/A Digger O'Toole of Opa Locka, Florida, with the total bid amount of \$777,764.48 for Bid Item Number 1 through Bid Item No. 38, plus Bid Item 47 – Owner's Contingency.

NOW THEREFORE, BE IT RESOLVED by the City Commission of the City of Weston, Florida:

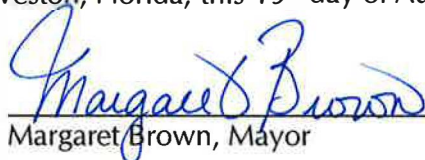
Section 1: The foregoing recitals contained in the preamble to this Resolution are incorporated by reference herein.

Section 4: This Resolution shall take effect upon its adoption.

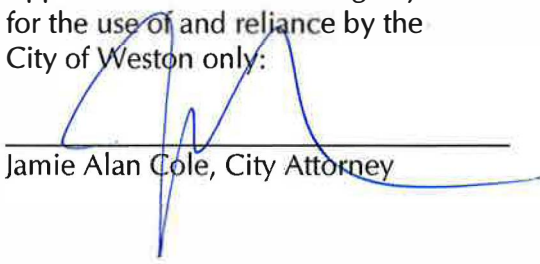
