A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF WESTON, FLORIDA, AND AS THE GOVERNING BOARD OF THE INDIAN TRACE DEVELOPMENT DISTRICT, AWARDING BID NO. 2024-06, PURCHASE OF LUMEC ROADSTAR STREET LIGHTING LED FIXTURES, TO THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, CHAMPS PRO SERVICES OF HOLLYWOOD, FLORIDA; AND IF THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER DOES NOT EXECUTE THE CONTRACT OR OTHERWISE FAILS TO PERFORM FOR ANY REASON, AUTHORIZING THE CITY MANAGER TO AWARD TO THE SECOND LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, SESCO LIGHTING, INC. OF CORAL SPRINGS, FLORIDA.

WHEREAS, First, the Indian Trace Development District (ITDD) is a dependent special district of the City of Weston for the purpose of exercising all those rights, powers and authority contained in Chapter 189 and 190, Florida Statutes; and

WHEREAS, Second, the City of Weston (the "City") owns, operates and maintains City roadways including the street lighting infrastructure which includes the LED street light fixtures; and

WHEREAS, Third, funding was appropriated in the Fiscal Year 2024 Budget, Indian Trace Development District – Basin I Rights-of-Way Fund, Street Light Fixture Replacement for the purchase of LUMEC Roadstar LED Street Light Fixtures manufactured by Signify; and

WHEREAS, Fourth, the U.S. Department of Energy approved the City's application for Energy Efficiency and Conservation Block Grant (EECBG) Program Equipment Rebate Voucher for the purchase of LED street light fixtures; and

WHEREAS, Fifth, Chapter 32 of the City Code governs the acquisition of goods and services and disposal of City property, including the Purchase Of Lumec Roadstar Street Lighting LED Fixtures, Bid No. 2024-06 (the "Bid"); and

WHEREAS, Sixth, in compliance with Chapter 32 of the City Code, beginning on May 30, 2024, the Bid was issued and advertised in the Sun-Sentinel, on the City's website, posted on the Public Notices board in the City Hall lobby, and bid documents were made available for electronic download from the City's website and Onvia DemandStar; and

WHEREAS, Seventh, on June 10, 2024, the City issued Addendum #1, on June 12, 2024 Addendum No. 2 was issued and on June 20, 2024 Addendum No. 3 was issued; and

WHEREAS, Eighth, on June 24, 2024, bids were due and opened and the City received six (6) sealed bids from: Bell Electric Supply, Co. of Woodside, New York; Champs Pro Services of Hollywood, Florida; Sesco Lighting, Inc. of Coral Springs, Florida; Supreme Lighting Design, LLC of Brooklyn, New York; Torres Electrical Supply Company, Inc. of Stuart, Florida; and World Electric Supply, Inc. of Pompano Beach, Florida, as shown on the Bid Tabulation, attached as Exhibit "A"; and

WHEREAS, Ninth, on July 5, 2024, the Selection Committee, consisting of Bryan Cahen, Director of Budget; Kara Petty, Director of Parks and Recreation; and Andrew Matusevich, Assistant Director of Landscaping, met at a publicly noticed virtual meeting held using Cisco Webex, to review the bids and determined all six (6) bidders to be responsive and responsible; and

WHEREAS, Tenth, the Selection Committee determined Champs Pro Services of Hollywood, Florida, as the responsible and responsive bidder with the lowest cost with a total bid amount of \$113,580.21 and Sesco Lighting, Inc. of Coral Springs, Florida as the responsible and responsive bidder with the second lowest cost with a total bid amount of \$141,650.00; and

WHEREAS, Eleventh, the City Commission finds that the responsible and responsive bidder with the lowest cost for Bid No. 2024-06 for the Purchase of Lumec Roadstar Street Lighting LED Fixtures, is Champs Pro Services of Hollywood, Florida with the total bid amount of \$113,580.21 and Sesco Lighting, Inc. of Coral Springs, Florida as the responsible and responsive bidder with the second lowest cost with a total bid amount of \$141,650.00.

NOW THEREFORE, BE IT RESOLVED by the City Commission of the City of Weston, Florida, and as the governing board of the Indian Trace Development District:

<u>Section 1:</u> The foregoing recitals contained in the preamble to this Resolution are incorporated by reference herein.

<u>Section 2</u>: Bid No. 2024-06 for the Purchase of Lumec Roadstar Street Lighting LED Fixtures is awarded to Champs Pro Services of Hollywood, Florida as the lowest responsible and responsive bidder, with a total bid amount of \$113,580.21.

<u>Section 3</u>: If the lowest responsive and responsible bidder does not execute the contract or otherwise fails to perform for any reason, the City Manager is authorized to award to the second lowest responsive and responsible bidder, Sesco Lighting, Inc. of Coral Springs, Florida with a total bid amount of \$141,650.00.

<u>Section 4:</u> The appropriate City officials are authorized to execute all necessary documents and to take any necessary action to effectuate the intent of this Resolution.

Section 5: This Resolution shall take effect upon its adoption.
