A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF WESTON,
FLORIDA, AWARDED BID NO. 2024-07 FOR GATOR RUN PARK
IMPROVEMENTS TO VERCETTI ENTERPRISES, LLC OF MIAMI, FLORIDA.

WHEREAS, First, the City of Weston (the "City") owns, operates and maintains Gator Run Park located at 1101 Park Blvd., Weston, FL 33327; and

WHEREAS, Second, funding is appropriated in the Fiscal Year 2024 Budget, Capital Projects Fund; and

WHEREAS, Third, Chapter 32 of the City Code governs the acquisition of goods and services and disposal of City property, including Gator Run Park Improvements, Bid No. 2024-07 (the "Bid"); and

WHEREAS, Fourth, in compliance with Chapter 32 of the City Code, beginning on June 28, 2024, the Bid was issued and advertised in the Sun-Sentinel, on the City's website, posted on the Public Notices board in the City Hall lobby, and bid documents were made available for electronic download from the City's website and Onvia DemandStar; and

WHEREAS, Fifth, on July 10, 2024, the City issued Addendum #1; and

WHEREAS, Sixth, on July 11, 2024, ten (10) individuals from a total of eight (8) firms participated at the mandatory Pre-Bid Conference held virtually through Cisco Webex; and

WHEREAS, Seventh, on July 12, 2024, the City issued Addendum #2 and on July 26, 2024 Addendum No. 3 was issued; and

WHEREAS, Eighth, on July 29, 2024, bids were due and opened and the City received four (4) sealed bids from: Waypoint Contracting, Inc. of Doral, Florida; Bejar Construction, Inc. of Pembroke Pines, Florida; Vercetti Enterprises, LLC of Miami, Florida; and Rycon Construction, Inc. of Sunrise, Florida, as shown on the Bid Tabulation, attached as Exhibit "A"; and

WHEREAS, Ninth, on August 1, 2024, the Selection Committee consisting of Bryan Cahen, Director of Budget; Thaddeus Bilecki, Director of Landscaping; and Jerrylee Camacho, IT Manager, met at a publicly noticed virtual meeting held using Cisco Webex, to review the bids; and

WHEREAS, Tenth, the Selection Committee deemed all four (4) firms as responsive and responsible and determined Vercetti Enterprises, LLC of Miami, Florida as the responsible and responsive bidder with the lowest cost, in the total bid amount of \$1,470,975.00; and

WHEREAS, Eleventh, the City Commission finds that the responsible and responsive bidder with the lowest cost for Bid No. 2024-07, Gator Run Park Improvements is Vercetti Enterprises, LLC of Miami, Florida, with the total bid amount of \$1,470,975.00.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF WESTON, FLORIDA, AWARDED BID NO. 2024-07 FOR GATOR RUN PARK IMPROVEMENTS TO VERCETTI ENTERPRISES, LLC OF MIAMI, FLORIDA.
