

NOTICE TO PROPOSERS

NOTICE IS HEREBY GIVEN that the City of Weston, Florida, the Bonaventure Development District, and the Indian Trace Development District (collectively known as the "City") will be accepting sealed proposals for:

ENTERPRISE RESOURCE PLANNING (ERP) SOFTWARE AND IMPLEMENTATION SERVICES REQUEST FOR PROPOSALS ("RFP") NO. 2017-05

With this Request for Proposals ("RFP"), the City of Weston, FL (the "City") desires to purchase or otherwise acquire rights to use an Enterprise Resource Planning ("ERP") System that meets the requirements identified in this RFP. The City requires that any proposal for an ERP also include professional services necessary to implement the system. The City's business model is to outsource business functions. Proposers offering hosted services or software as a service ("SaaS") systems are encouraged to propose.

PROPOSAL SUBMITTAL DEADLINE

Sealed proposals will be received by the City Clerk until 11:00 a.m., local time, June 27 July 6, 2017 (the "Proposal Submittal Deadline") at the City of Weston, City Hall, located at 17200 Royal Palm Boulevard, Weston, Florida, 33326. The time displayed on the official clock at the City Hall Reception Desk shall govern. Proposals received after this time will be returned unopened. The Sealed Proposals will be publicly opened at the City of Weston, City Hall after the Proposal Submittal Deadline. Award of the Proposal will be made at a City Commission meeting.
